#### **ACTION REQUESTED**

Approve the award of competitive Bid No. 9762 to TiFCo Industries for fasteners and related items in the maximum aggregate amount of \$63,000.00, and authorize the Purchasing Manager to sign four resulting Blanket Purchase Orders (BPOs).

#### **BACKGROUND**

The Procurement Services Division, on behalf of the Department of Public Works (DPW) - Fleet Services, Placer County Fire, Facility Services, and the Placer County Sheriff's Department solicited bids for the County's fastener requirements. Twenty-six vendors were notified of Invitation for Bid (IFB) No. 9762 which was also posted on the County's website. The Bid stated that the County intends to award four BPOs to the lowest responsive bidder for an approximate initial one year period with possible annual renewals in accordance with the Bid's specifications. Bids were received from six vendors: D&S Products Company, Fastenal Company, Grayson Industries, Inc., MRO Club, Riebes Auto Parts, and TiFCo Industries.

Bid evaluation was based on the lowest bid reference total. Local vendor's preference (LVP), payment discounts, and related item discounts were also considered during the award evaluation and LVP was not a determinant in the award recommendation. Initial bid evaluation showed that the apparent low bidder was Grayson Industries, Inc. of Plantation, FL; however, Grayson Industries has discontinued their sales representative visitation program. Bid specifications state that the successful firm shall provide a sales representative to visit each delivery location at least every two weeks. In accordance with the Purchasing Policy Manual, Section 3.14, this bid was rejected because of the variance with specifications. The next lowest bidder, TiFCo Industries of Citrus Heights, CA, has the ability to provide a sales representative to visit the delivery locations every two weeks.

Four BPOs have been requested by the following departments and are recommended for approval in the following maximum amounts: DPW, Fleet Services - \$36,000.00, Placer

County Fire - \$10,000.00, Facility Services - \$15,000.00, and Placer County Sheriff's Department - \$2,000.00. Based on their complete responsiveness to the bid and their favorable pricing, staff recommends approval to award the resulting BPOs to TiFCo Industries in the maximum aggregate amount of \$63,000.00.

#### **FISCAL IMPACT**

The BPOs resulting from this recommendation will provide the County's fastener requirements in the maximum aggregate amount of \$63,000.00. The Departments' Fiscal Impact Statements are attached.
