SUBJECT: Approve re-appropriation of \$10,000 of Secure Rural Schools & Community Self-Determination Act of 2000 and the Emergency Economic Stabilization Act of 2008 Title III discretionary funds allocated toward Defensible Space Inspections to manage the accumulation of fuels generated through Defensible Space projects.

Approve two projects from the Emergency Economic Stabilization Act of 2008 Title III discretionary funds, in the amount of \$55,000.

ACTION REQUESTED

1. Re- appropriate \$10,000 of the Title III discretionary funds from FY 2010/2011 budget, previously allocated by the Board through the Secure Rural Schools & Community Self-Determination Act of 2000 and the Emergency Economic Stabilization Act of 2008 for Defensible Space Inspections. Reallocation will fund managing the accumulation of an anticipated increase in fuel levels due to the drought conditions over and above what is currently generated during defensible space projects. These dollars will be used as matching funds to support a Clean Air Grant for Green Waste Bins and biomass removal for public defensible space clearing and Firewise projects.
2. Approve two projects from the Emergency Economic Stabilization Act of 2008, Title III discretionary funds, in the amount of \$55,000 for,
 - a. Fire mitigation program oversight - \$45,000
 - b. Search and Rescue on Federal Lands - \$10,000
3. The 45 day public noticing for each project has been completed. There was no additional input received from the community during the noticing period. Request final approval of the planned expenditures.

BACKGROUND

Public Laws:

The Secure Rural Schools & Community Self-Determination Act HR 2389 aka Public Law (PL) 106-393, was enacted in October 2000 to offset the loss of revenues in rural counties due to declining timber harvests and the decrease of income generation on federal lands. It provided

qualifying counties with predictable funding for rural schools and roads for federal fiscal years (FFY) 2001 through 2006 and was extended by Congress through FFY 2007. Despite the extension, spending is limited to previously approved methods or projects.

In October, 2008, Congress enacted the Emergency Economic Stabilization Act of 2008 (PL 110-343) which included reauthorization of the "Secure Rural Schools" program. However, this law has a significantly lower level of funding and restricts the use of funds to supporting:

- Activities under the *Firewise Communities* program
- Reimbursement for search and rescue (SAR) on federal lands
- Development of community wildfire protection plans (CWPP)

Recommended use of funds:

PL 110-343: Staff recommends the following uses of funds the result of which increases the protection of people and properties from wildfires and supports the Sheriffs' Office search and rescue operations on Federal lands. In summary, funds are to be allocated as indicated:

There is no impact to the General Fund as a result of these actions. There is adequate fund balance in Placer County's Forest Reserve Title III fund to support these activities.

ATTACHMENT A

Description of recommended projects to receive Title III discretionary funds support

PL 110-343:

PROJECT #1: FIRE MITIGATION COORDINATOR

Issue/Background: This project continues to fund the Placer County Fire Mitigation Coordinator, a part time contract position, for 2013/2014. The Coordinator represents the County with citizen groups, fire safe councils, the Fire Safe Alliance and fire departments/districts involved in wildfire protection planning. He assists with public education, fire mitigation project planning and implementation as well as coordination between professional and community organizations in implementing fuel reductions. The Coordinator seeks is building a community-based fire mitigation vision with consistent goals.

Alternatives: Allow fire mitigation departments, districts, fire safe councils, etc. to operate alone. However, this method forfeits optimization of programming and scarce funding.

Responsible Office: Office of Emergency Services

Funds to be Obligated: \$45,000

PROJECT #2: SEARCH AND RESCUE (SAR) OPERATIONS ON FEDERAL LANDS

Issue/Background: This project makes funds available to support search and rescue operations (performed primarily by Sheriff's volunteers) on federal land in 2013/2014. The funding covers SAR costs such as fuel, equipment and supplies, maps, and food for personnel as well as for search and rescue animals. This project has been funded at the \$10,000 level each year since 2006.

Alternatives: Conduct federal land SAR without reimbursement, but that puts future or other operational capabilities in jeopardy.

Responsible Office: Sheriff's Office

Funds to be Obligated: \$10,000.

PROJECT #3: DEFENSIBLE SPACE CLEARING AND BIOMASS / GREEN WASTE BIN PROGRAM:

Issue/Background: As the impacts of the drought conditions in the County increase, the Placer County Fire Safe Alliance, Fire Safe Councils and participating agencies are encouraging the

public to follow through on PRC 4291 requirements. To provide options to the public to complete their defensible space requirements and fuels management, the County has developed options for removal of dead or dying tree and brush trimmings, pine needles, and leaves. Options include Green Waste Bins for community projects or individuals with a large amount of green waste. To fund this project the Placer County has applied for, and received confirmation of a \$30,000 Clean Air Grant from Placer County Air Pollution Control District. This request re-obligates PL 110-343 funds (\$10,000) to be utilized as matching funds for support of projects that promote woody biomass capture and usage through our biomass box program and our regional collection sites to the nearest biomass-to-electricity facility in the Placer County

Alternatives: Biomass material produced through defensible space and fuels management programs would be piled and burned or left in place to decompose, or residents may choose to not perform their defensible space because they do not have the means to remove the material from their property.

Responsible Office: CDRA/Planning Division

Funds to be re-Obligated: \$10,000

**PUBLIC INPUT SOLICITED BY
PLACER COUNTY OFFICE OF EMERGENCY SERVICES**

At its regular meeting on Tuesday, May 20th, the Placer County Board of Supervisors announced that, after a 45-day public comment period, it intends to approve two projects obligating a total of \$55,000 in Federal funds and re-appropriating \$10,000 of the Title III discretionary funds. However, before it can officially approve the projects, the Board is legally required to solicit input from the general population.

All of the funding was allocated to Placer County under Title III of the Fiscal Year 2000 Public Law (PL) 106-393, the Secure Rural Schools & Community Self-Determination Act (HR2389), and the remainder was reauthorized under PL 110-343 aka the Stimulus Act in 2009.

After review by the Office of Emergency Services and members of the Placer County Fire Safe Alliance, an organization comprising representatives of the Foresthill, Greater Auburn Area, Placer-Sierra and Rural Lincoln Fire Safe Councils, as well as by other local, state and federal agencies involved in land management and fire suppression, the funds were allocated as noted below:

1. Re-appropriate \$10,000 of the Title III discretionary funds from FY 2010/2011 budget, previously allocated by the Board through the Secure Rural Schools & Community Self-Determination Act of 2000 and the Emergency Economic Stabilization Act of 2008 for Defensible Space Inspections. Reallocation will fund managing the accumulation of an anticipated increase in fuel levels due to the drought conditions over and above what is currently generated during defensible space projects. These dollars will be used as matching funds to support a Clean Air Grant for Green Waste Bins and biomass removal for public defensible space clearing and Firewise projects.
2. Approve two projects from the Emergency Economic Stabilization Act of 2008, Title III discretionary funds, in the amount of \$55,000 for:
 - a) Fire mitigation program oversight - \$45,000
 - b) Search and Rescue on Federal Lands - \$10,000

In summary, funds are to be allocated as indicated:

- Fire Mitigation Coordinator -	\$45,000
- Search and Rescue on Federal Lands -	\$10,000
- Biomass/Green Waste Bin Program	\$10,000
